



Duplication Request Form

Notice Concerning Copyright Restrictions

The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material.

Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction. One of these specified conditions is that the photocopy or reproduction is not to be “used for any purpose other than private study, scholarship or research.” If a user makes a request for, or later uses, a photocopy or reproduction for purposes in excess of this “fair use,” that user may be liable for copyright infringement.

This institution reserves the right to refuse to accept a copying order if, in its judgment, fulfillment of the order would involve violation of the copyright law.

In compliance with the copyright law, Special Collections of Albion College limits the number of copies of each item to one. Furthermore, we cannot copy all or substantially all of a work for you, unless an unused copy of the work cannot be found at a fair price.

In addition, we reserve the right to restrict the use or reproduction of rare, valuable, or fragile items; to ensure that the use of the reproductions is in good taste; to make special quotations on items involving unusual difficulty in copying; to charge a use fee for staff time to fulfill this reproduction request; and to request destruction of the copy after use of it is complete.

We may deny duplication requests if, in the judgment of staff, such copying will harm the original item(s) or is prohibited by donor arrangement or U.S. copyright law.

In making copies available, Special Collections does not thereby grant permission to reproduce those copies or to quote extensively from them for publication, but in authorizing publication of its material, Special Collections does not surrender its own right to publish or grant others permission to do so in the future.

Special Collections processes orders as quickly as possible, but requests from on-site researchers take precedence. Research requests received through the mail, by phone or electronically will be handled as time and staffing allow.

Special Collections reserves the right to change these policies without prior notice.
